Comment: "Dear Sir/Madam, It's been a while since The Gem State Water Co (GMS Co) last increased it's rates. I can't remember what year it was so for the purposes of this I'm going to guess it's been 5 years. They probably are due a rate increase and given inflation it makes sense. However the proposed rate increases are wildly larger than inflation. From the internet inflation calculators, cumulative inflation since 2017 seems to have been about 15% to 20%. The income received by GMS Co is supposed to provide maintenance, improvements, and running expenses. There is nothing in the letter sent to us pointing to a prudently unforeseeable situation justifying any rate increase beyond that to cover inflation. Comment: "We are on fixed income SS and we object to a 68% for our water bill. Thank you"

In 2007 our water bill base was about \$12.00 a month and we had an allowed amount of 12 (units of measure?) with that. We moved here to retire and have our set income planned. Then in 2014 a new company had taken over our water company and raised (DOUBLED) the base to 25.55 plus a lower base usage which is now down to 10.7 and a higher cost if you went over that. When your people came up here to help "mediate"???, the one lady just said they never promised us a yard that could be watered!!! We have a lot of people here with animals and gardens, which your PUC people said we are not entitled to any of that!! I use a lot of water just helping clean and maintain 10.55 acres. At the time of the last proposed increase GEM STATE claimed that they needed it to fix and upgrade equipment. Well, what is it for now?? How much profit is this company making at our expense? This is, basically, a public utility, and last time the PUC told us that they really had no say in it anyway???? We are in recession in case you did not hear about it. Coeur D'Alene, ID -- On July 21, 2022 -- Gem State Water Company filed an application with the Idaho Public Utilities Commission (IPUC) for a proposed general rate increase to become effective September 1, 2022. The filing is subject to public review and a Commission decision before it can take effect.

Gem State Water Company seeks approval to increase rates to recover the current cost of operating and maintaining the water systems, which have escalated in recent years, prudently incurred system improvements, and recent investments to replace aging infrastructure required to provide water service to customers.

If approved the proposed increase would increase the Company's total annual revenues by \$402,000, or 69.9%. The table below shows the current and proposed typical monthly bill and proposed increase for customers using an average of 15,000 gallons.
