Comment: Please do not approve sale of Eagle Water to Suez. I am an Eagle Water consumer. My friends moved into a part of Eagle with Suez water. They were out of town for several weeks this summer. During that time, they were contacted by their HOA that there had been possible contamination in their water lines due to an incorrectly placed part that potentially allowed irrigation water to contaminate residential water. I went to my friends' house and followed the directions to flush their water pipes. A few days later, they were contacted again by the HOA that initial instructions were not thorough enough. I returned to the home again and followed the more extensive pipe flushing directions. Hopefully, no one on their water system became ill during the confusion of this situation. I ask the Idaho Public Utilities Commission to consider the first right of refusal of Eagle city to purchase Eagle Water. In addition, I request no sale to Suez due to this poor personal experience with them.

Our neighborhood was provided access to water through Eagle Water company several years ago by an LID supported by Ada County and its Commissioners. Prior to having Eagle water, our private wells provided inconsistent water quality, quantity and unreliable water pressure. We also lacked access to a community water system for fire protection. We now enjoy excellent water quality, volume and fire protection which we feel are essential for health, safety and quality of life.

We urge the IPUC to hold a meeting in Eagle to allow public testimony.

We oppose the sale to Suez as they are an international company and it is unclear how those water resources will be utilized and managed under their control.
