I am submitting these comments in opposition to the Contributions in Aid of Construction or CIAC.

When I learned about a new fee being charged by Suez and authorized by the Idaho Public Utilities Commission (Contributions in Aid of Construction or

- Contributions in Aid of Construction which is an additional 21.5% to the cost of the water system.
- The cost would increase the price of each home over \$2,500 per home.
- The new CIAC fee creates a distinct competitive disadvantage to private systems. Since the CIAC charges
 only apply to private water systems, the increased costs are inequitably charged to new development
 depending on its water provider.
- If a new development is served by a private water system like SUEZ, the CIAC is charged; but the fee is not charged if the development is served by a government owned water system.

Comment: "Our small community (Riverland Terrace) consists of 29 dwellings of which at least 17 are owner occupied by retired seniors on fixed income. The project to connect with the SUEZ water system and abandon three wells we own was necessitated by DEQ regulations when higher than normal arsenic levels were found in our water supply shortly after several Harris Ranch subdivisions started bordering our community. Compliance with DEQ regulations would have required expensive upgrades estimated in the hundreds of thousands of dollars to our three wells, well beyond what the community felt it could afford. Options available to us were limited and it was felt that the better option was to hook up with Suez water. Unfortunately, the cost of this transition is turning out to be higher than expected. This is due in part by high contractor costs quoted by Suez as well as a tax levied by the Idaho Public Utility Commission on new developer projects. We feel that this is an unfair tax that Suez intends to pass on to us. Furthermore our subdivision is not part of a new developer project as we have been in existence since the 1970s. Since our residents are already burdened with the high costs related to this project, this seems to be an additional burden to pass on. We respectfully request that you waive this fee that our community certainly cannot afford.
