On February 28, 2024, CDS Stoneridge Utilities, LLC ("Company") filed an application with the Idaho Public Utilities Commission ("Commission") requesting an order approving an increase in rates and charges for water service.

On December 24, 2024, the Commission issued Order No. 36407 approving an increase in rates and charges and ordering the Company to submit a compliance filing with updated tariffs conforming with the order.

The Company petitioned for reconsideration of Order No. 36407, and on May 6, 2025, the Commission issued Order No. 36593, granting in part and denying in part the Company's petition. The Commission ordered the Company to submit updated tariffs in conformity with the order. Order No. 36593 at 16.

Additionally, on March 24, 2025, the Commission issued Order No. 36522, in Case No. SWS-W-06-01, directing the Company to cease collections of the \$2.65 surcharge to the Happy Valley Ranchos Subdivision customers after the Company's April 2025 billing cycle.

On June 6, 2025, the Company submitted updated tariffs in this case.

## **COMMISSION FINDINGS AND DECISION**

The Commission has jurisdiction over the Application and the issues in this case under Title 61 of the Idaho Code including *Idaho Code* §§ 61-301 through 303. The Commission is empowered to investigate rates, charges, rules, regulations, practices, and contracts of all public utilities and to determine whether they are just, reasonable, preferential, discriminatory, or in violation of any provisions of law, and to fix the same by order. *Idaho Code* §§ 61-501 through 503.

Having reviewed the record and all submitted filings, the Commission finds that the Company's updated tariffs submitted through a compliance filing on June 6, 2025, conform with the provisions of the Commission's orders.

## **ORDER**

IT IS HEREBY ORDERED that the Company's updated tariffs submitted through a compliance filing on June 6, 2025, are approved.

THIS IS A FINAL ORDER. Any person interested in this Order may petition for reconsideration within twenty-one (21) days of the service date upon this Order regarding any matter decided in this Order. Within seven (7) days after any person has petitioned for reconsideration, any other person may cross-petition for reconsideration. *Idaho Code* §§ 61-626.
