In addition, because non-potable irrigation water is unavailable at our location for landscaping purposes, the proposed water rate increase will have a disproportionate effect on our household and others similarly situated.

In water rate cases of Veolia Water Idaho Inc.'s predecessors, including United Water Idaho and Boise Water Corporation, Sharon served as an official intervenor on behalf of the water utility's ratepayers.
