Their notification to their customers was presented as investments and improvements to their system, with fine print on the back that let us know they were seeking to increase rates with the Idaho Public Utilities Commission. This does not meet the intent of notifying customers of rate increases and presenting the case for their need. Veolia's request should be denied because it is exorbitant, was not put forward for customer approval of costs beforehand, and is presented to customers in a misleading way."
