Staff is aware that Atlanta Power Customers are interested in system upgrades without corresponding increases in their power rates. To that end, Staff wishes to inform you of a U.S. Department of Agriculture (USDA), Rural Utilities Service (RUS) competitive grant program (\$75,000 minimum) for energy facilities serving rural communities with extremely high energy costs. Although Staff does not apply for grant funding in the course of its duties, we did indicate at the Atlanta Power public workshop that grant money may be available to make system improvements and funding provided by the USDA is one such program. The following briefly describes the criteria and process to apply for a grant under this RUS program. It is Staff's understanding that Atlanta Power President Israel Ray is interested in pursuing this funding to improve electrical service to the community.
